

**DETERMINATION AND FINDINGS

SOLE SOURCE PROCUREMENT**

1. **Authorization**<sup>i</sup>

2. **Minimum Need:**

The Office of the People's Counsel (OPC) requests the services of Squire Patton Boggs (US) LLP to provide legal services related to employment and human resource matters.

3. **Estimated Fair and Reasonable Price:**

\$ 25,000

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel (OPC) is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Squire Patton Boggs (US) LLP is a full-service global law firm with offices in Washington, DC. Squire Patton Boggs (US) LLP's Labor & Employment Practice Group is one of the largest global labor and employment practices in the world.

The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any by nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
